I, Rasna Goyal (FCS: 9096, CP No.: 9209) Companies Secretary in whole-time practice **Partner in Leena Agrawal & Co., Practicing Company Secretaries**, having office at 204, Mhatre Pen Building, Senapati Bapat Marg, Dadar(west), Mumbai-400028, was appointed as Scrutinizer by the Board of Directors of **M/s CHASE BRIGHT STEEL LIMITED** to act as the Scrutinizer to scrutinize the remote e-voting process and e-voting conducted at the Annual General Meeting ("AGM") under the provisions of Section 108 of the Companies Act, 2013 read with Rules 20 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) and General Circular No.20/2020 dated 5th May, 2020 read with circular dated 8th April,2020 and 13th April, 2020 and General Circular No.02/2021 dated 13th January, 2021 and MCA Circular No. 2/2022 dated May 05, 2022, General Circular No.10/2022 Dated December 28,2022 General Circular No. 09/2023 dated 25.09.2023 and the and latest being General Circular No. 09/2024 dated 19.09.2024 issued by the Ministry of Corporate Affairs ("MCA") and in accordance with the circular dated 12th May, 2020 read with the circular dated 15th January, 2021 and Circular dated

January 05, 2024 and other relevant circulars issued by the Securities and Exchange Board of India ("SEBI") commonly referred to as "MCA & SEBI CIRCULARS" in a fair and transparent manner in respect of the Resolutions passed at the AGM of M/s CHASE BRIGHT STEEL LIMITED at their Meeting held on Tuesday, 30th September, 2025 at 11.00 A.M. by Video Conferencing (VC)/Other Audio-Visual Means (OAVM).

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and related Rules in respect of voting through electronic means i.e. Remote E-Voting and E-Voting System conducted at the AGM on the Resolutions contained in the notice of the 65th Annual General Meeting "AGM" of the Company.

As Scrutinizer for Remote E-Voting process and E-Voting conducted at the AGM, my responsibility is to provide the Scrutinizer's Report of the votes cast in "FAVOUR" or "AGAINST" the resolutions stated in the notice, based on the votes casted through E-Voting System during AGM as per reports generated from the e-voting system provided by the Central Depository Services India Ltd "(CDSL)", the authorised agency engaged by the Company to provide remote e-voting facility and e-voting system at the AGM.

I hereby submit my report as follows:

- The resolutions as mentioned in the Notice of AGM were transacted through the process of Remote E-Voting and through E-Voting System at the AGM. For the purpose of Remote E-Voting and E-Voting System at the AGM, the Company has engaged the services of the Central Depository Services India Ltd "(CDSL)";
- 2. Members attended the meeting through VC/OAVM facility provided in accordance with the General Circular No.20/2020 of May 5, 2020 and other circulars issued by the Ministry of Corporate Affairs ("MCA") from time to time and were counted for the purpose of reckoning quorum under section 103 of the Companies Act, 2013.
- 3. The shareholders of the Company holding shares as on the "cut-off" date i.e. 23rd September, 2025 were entitled to vote on the Resolutions as contained in the notice of the AGM.
- 4. The remote e-voting commenced from Saturday, 27th September, 2025 at 09.00 a.m. and ended on Monday, 29th September, 2025 at 5.00 p.m. and remote e-voting was blocked thereafter by CDSL.
- 5. At the end of the voting period on 29th September, 2025 at 5.00 P.M., the voting portal of the Service Provider was blocked forthwith.
- 4. Further, the votes cast through Remote E-Voting and E-Voting System during the AGM was unblocked by me at 4.55 p.m on 30th September, 2025 in the presence of two witnesses, neither of whom was in the employment of the Company and e-voting summary statement was downloaded from the e-voting website.
- 5. The votes were also scrutinized for the purpose of eliminating duplicate voting of votes, if any;
- 6. Our report on the results of e-voting is based on the data downloaded from the website of CDSL;
- 7. The data relating to e-voting process were reconciled with the records maintained by the Company/Registrar and Transfer Agents of the Company.
